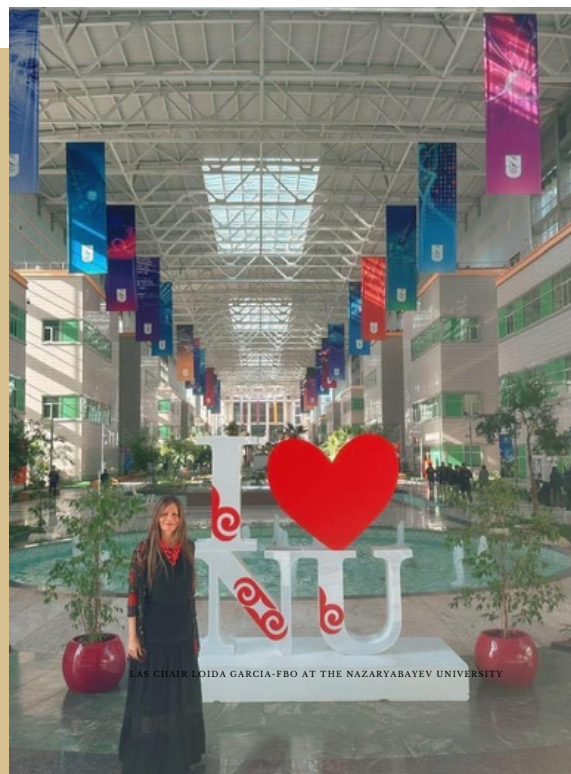

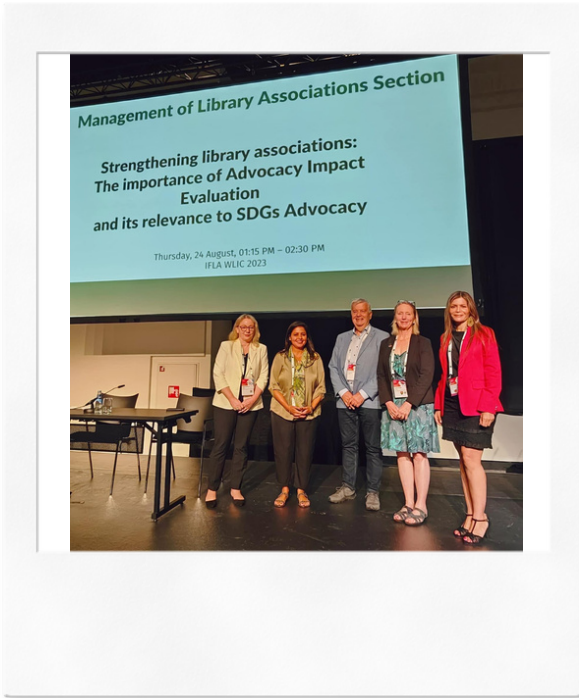

IFLA MLAS Advocacy Impact Evaluation Project 2021-2024

The IFLA MLAS Advocacy Impact Evaluation Project started in November 2021 with the aim to increase awareness and raise understanding of the challenges and benefits of advocacy impact measurement and evaluation practice for the library field. The project has been conducted by the IFLA MLAS Standing Committee members, led by Dijana Machala (Croatia) with an active participation from Susan Haigh (Canada), Hella Klauser (Germany), Jorge Moisés Kroll Do Prado (Brazil), Pascal Sanz (France) and Alicia Sellés Carot (Spain).



The purpose of the project is to set guidelines or recommendations for the library sector on how to evaluate the effectiveness or impact of the library advocacy activities. The aim of the project's output - The Strengthening Library Advocacy Impact Evaluation Practice - is to be a valuable tool for libraries, library associations and library professionals who want to go beyond designing, planning and measuring advocacy outputs and want to expand their knowledge on how to evaluate library advocacy impact and to measure the effects of change.

The project started with an exploratory phase. A literature review of research articles found in major scientific databases was conducted. The Working Group analyzed more than 180 multilingual papers organized within the Zotero web library. The Literature Review provided valuable information about theories, methodologies applied and examples of best practice in the field of measuring and evaluating the impact of advocacy. Although a great amount of professional literature that deals with library advocacy stresses the importance of advocating, providing interesting insights into successful case studies, innovative techniques applied, and sharing a plethora of practical advocacy tools to be used, there is still a lack of common understanding of the importance of library advocacy planning and evaluation.

We found a very little or a none evidence of systematic library advocacy impact evaluation reports. We thought this was due to the fact that it must be very hard for the library sector to familiarize with advocacy impact evaluation methods or techniques. And to avoid many pitfalls that occur during the process of planning, collecting, analyzing and presenting advocacy impact data in ways that it would be a reliable evidence of the level of their contribution to a desirable policy or societal change.

IFLA MLAS Advocacy Impact Evaluation Project 2021-2024- Continuation

As a follow-up to the literature review of the advocacy impact evaluation theories and researches, the working group conducted an online survey looking for the inputs from IFLA MLAS members (library associations) on their advocacy impact evaluation practice.

The aim of the survey was to get insight into the current state of the advocacy impact evaluation practice and to identify the examples of best practice. A survey was conducted during May 2023 with 113 responses received from all IFLA Regions.

The survey preliminary findings reveal that there is a great divide among those library association who attempts to formally evaluate advocacy activities (49%) and those who does not evaluate (50%), although 79% of respondents who evaluate advocacy activities attempt to evaluate impact.

The main reasons not to assess impact are: lack of resources (staff, money), lack of knowledge of methodology, lack of time to execute the evaluation and lack of assessment tools suitable for library field. More than a half (55%) of respondents agree that the advocacy impact evaluation is important in general, and that it should be priority for IFLA and for library sector, while at the same time 58% of respondents do not have experience in advocacy impact evaluation practice or do not have good understanding of advocacy impact evaluation methodologies.

One of the aims of the survey was to identify recognized library advocacy experts in all IFLA Region agreeing to be further interviewed by the working group with the aim of gathering their personal experiences with advocacy impact assessment and evaluation methods.

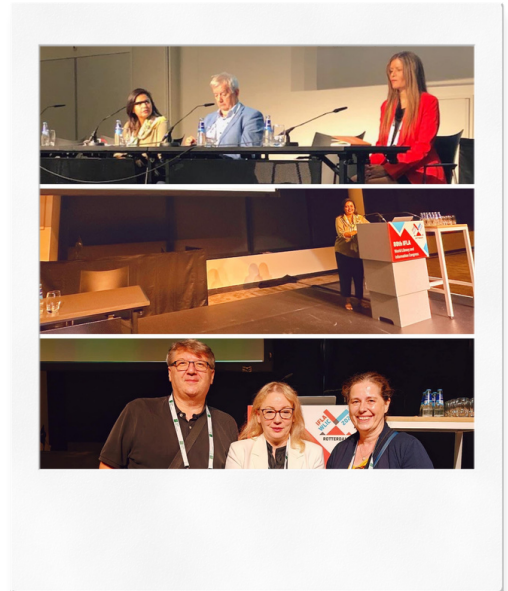

The project is in its final year. The Working Group is finalizing interviews with recognized experts from the field of the library advocacy impact evaluation with the aim to gather information about differences among advocacy impact evaluation practices from all the IFLA Regions. The Working Group is doing the analysis and guidance formulation with the aim that the final text of the project review *The Strengthening Library Advocacy Impact Evaluation Practice* be submitted to the Professional Council and IFLA Governing Board review and approval by end of the 2024.

IFLA MLAS Advocacy Impact Evaluation Project 2021-2024- Continuation

To conclude, some preliminary project findings:

- The Library Advocacy and its Impact Evaluation should be introduced into LIS curriculum.
- Impact evaluation is a key step, not an afterthought. It should be systematically planned from the beginning.
- It should be used to inform subsequent advocacy efforts.
- If you do it, make it publicly available to your stakeholders and community.
- It will be helpful to create and promote a framework or model for library advocacy impact evaluation.

IFLA MLAS + Regions: Supporting the Building of Strong Library Associations

Over the last years the IFLA Management of Library Associations Section (MLAS) has followed a strategy to engage closely with the regions of the world: Asia/Oceania, Europe, Latin America and the Caribbean, Middle East and North Africa, Sub-Saharan Africa and North America.

In 2021 MLAS created a series of videos, featuring interviews of library leaders from regions across the globe, discussing “Advocacy: The Power of Networking.” The videos are available on the MLAS YouTube Channel. The videos set the basis for MLAS multi-session event during WLIC 2021 where MLAS presented six online sessions featuring all IFLA regions including interactive conversations in languages spoken in the regions. The series concluded with a WLIC Open Session featuring regional leaders who presented advocacy highlights from their region.

In 2022 MLAS partnered with IFLA New Professionals Special Interest Group (NPSIG) to present the six-session webinar series “Empowering library leaders and diversity worldwide.”

Library associations in each region shared opportunities provided for new and senior librarians, including leadership opportunities and how library associations foster diversity within the library profession and leadership roles. Interactive conversations in regionally-based languages revealed that across the regions, mentoring and coaching are commonly-shared best practices and team building and skills for leading in times of crisis are the top recommendations. Improved communication and leadership training are the needs most frequently identified.



In 2023, IFLA’s Management of Library Associations Section (MLAS) collaborated with the New Professionals Special Interest Group (NPSIG), the IFLA Regional Divisions, and IFLA Environment, Sustainability and Libraries Section (ENSULIB) to present “Sustainable Development Goals and Library Associations,” a webinar series on the United Nations SDGs and Library Associations.

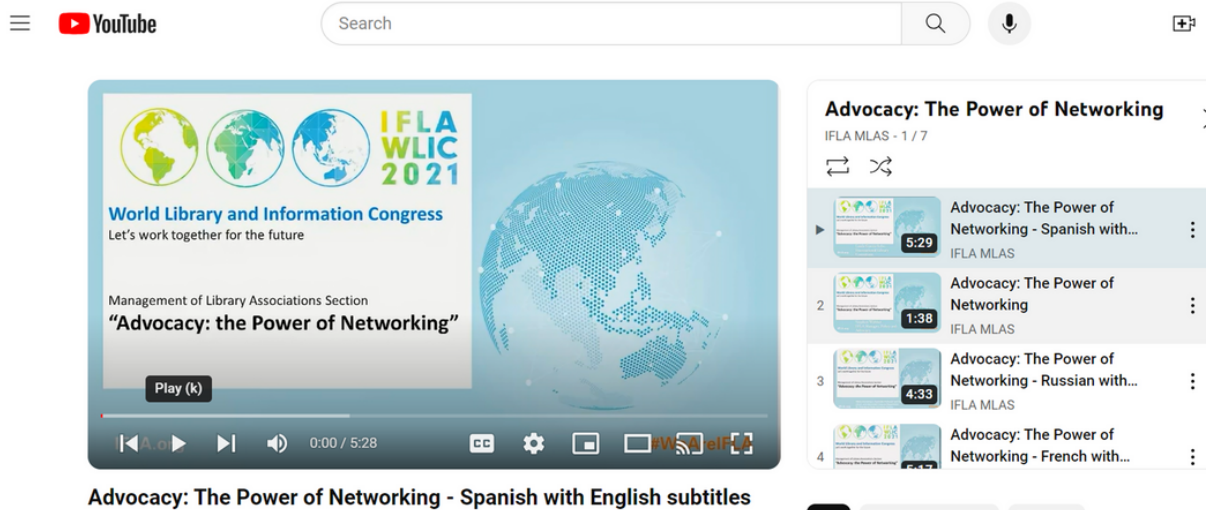
Each webinar was opened by a regional representative from the United Nations sharing insights and updates of work in the region.

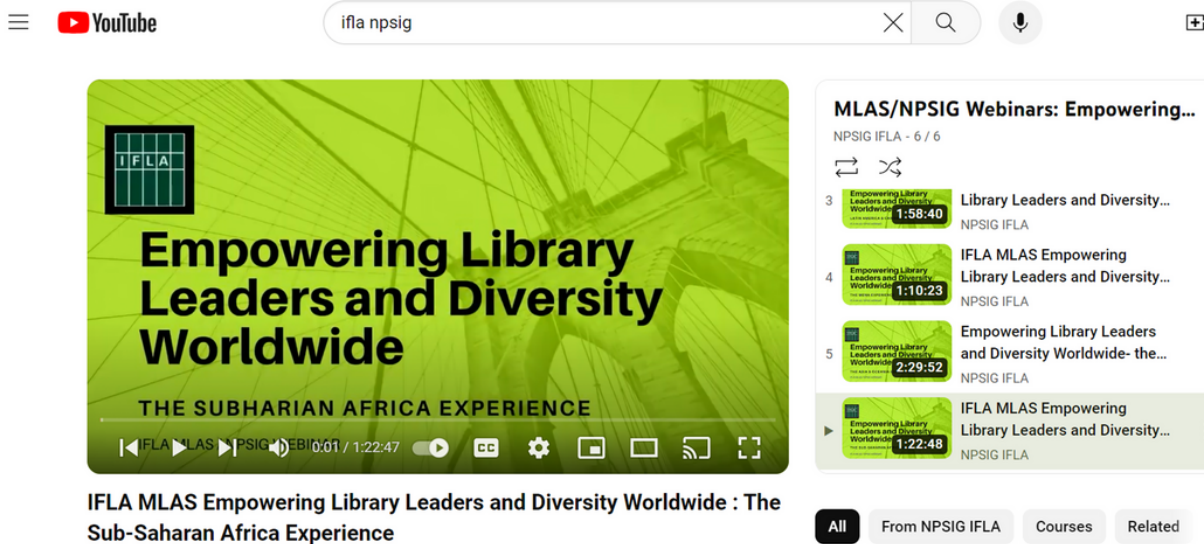

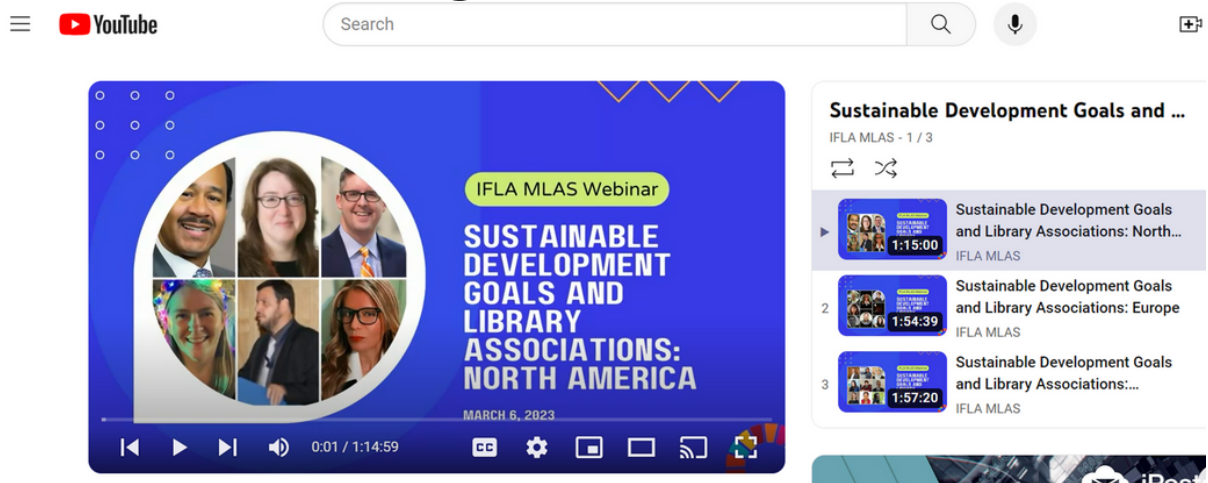

IFLA Women, Information and Libraries SIG

WILSIG prepared an Action Plan for 2023-2025 and, in line with it, there are formed three working groups:

- Preparation of WILSIG Newsletter in charge of Tu Shumin, with Molly, Sadaf and Jelisaveta;
- Preparation of three (for now) bibliographies on Children's book on Women Rights and Gender Equality in charge of Antonella with Molly and Erica;
- Improving communication tools via updating Facebook page on regular basis, updating WILSIG webpage on IFLA site, archiving of group's activities on Basecamp, etc.

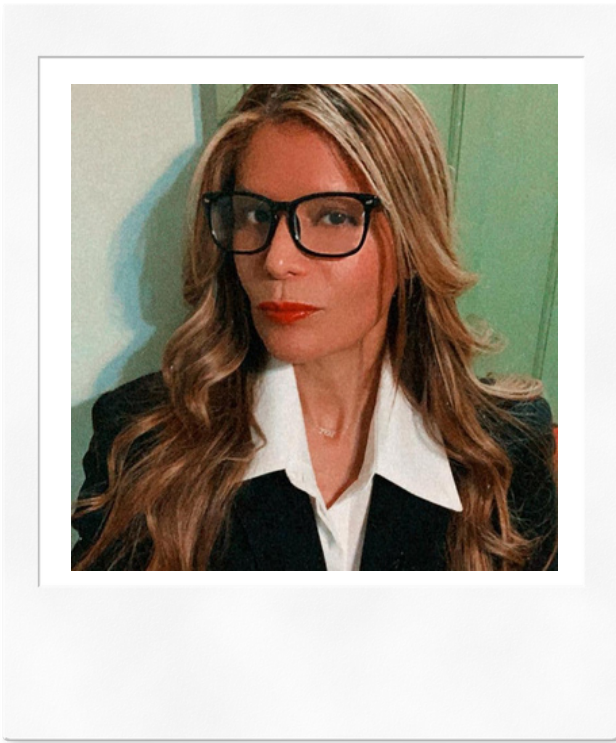
