CAPE TOWN PROGRAMS

RELEVANT TO LIBRARY THEORY AND RESEARCH

We hope many of you can attend the programs our Section is participating in at the Cape Town Conference.

- 1. The LTR Section is hosting a session on August 17th (09:30 12:45 Auditorium 1) on "Measuring the Impact of Access to Information and Development" together with the Statistics and Evaluation Section. Chairs: Yasuyo Inoue (Dokkyo University, Japan) and Britt Omstedt (University of Borås, Sweden).
- 2. The LTR Section's open session is scheduled on August 19th (09:30 12:45 Roof Terrace Room) on "Quality Assurance in LIS Education" together with the Education & Training and SIG LIS Education in Developing Countries Chair: Gillian Hallam (Australia). A Discussion Panel is planned at the end of the presentations, about QA policies around the

World: Mitsuhiro Oda (Aoyama Gakuin University, Japan), Dennis Ngong Ocholla (Department of Information Studies, University of Zululand, South Africa), Seamus Ross (University of Toronto iSchool, Canada), Sari Feldman (American Library Association, United States), and Anna Maria Tammaro (University of Parma, Italy)

- 3. LTR members will be interested to participate to the SIG Library History open session on August 16th (13:45 15:45 Ballroom East) on "Library History in Sub-Saharan Africa Library History SIG.
- 4. The LTR Section is also proposing Pre-Congress Satellite Conference of IFLA's Library Theory and Research Section. The Conference, on Digital Preservation as a Site of Contestation: National Heritage, Memory,

Politics and Power -- Beyond Technology and Management, will take place in Cape Town on 12 and 13 August 2015.

A varied and interesting program has been compiled. Day 1 will be presented on the campus of the University of the Western Cape, which was a center of resistance during the anti-apartheid struggle and which houses the Robben Island Museum Mayibuye Archive. A visit to this Archive is included as part of the program. The University is in the eastern suburbs of Greater Cape Town. Transport will be arranged to the campus from the Cape Town International Convention Centre (venue for the IFLA Congress), and back. On Day 2, participants will have an opportunity to visit Robben Island itself, weather permitting. They will make their own way to the Victoria and Albert Waterfront for the crossing to the Island. This will be followed by an afternoon session in Cape Town's District Six Museum, for which transport will be arranged. A preliminary program can be found here. If bad weather rules out the crossing to Robben Island, an alternative self-guided walking tour can be taken in Cape Town.

IFLA DE GRUYTER



AWARD

This IFLA award sponsored by IFLA and De Gruyter Saur and submissions were evaluated by a panel of LTR committee members: Anna Maria Tammaro (Chair), Krystyna Matusiak and Xiwen Liu. The award is aimed at encouraging original research and publication by those relatively new to the profession. This year's topic for the De Gruyter Saur IFLA Research Paper Award was Digital Libraries: knowledge creation and sharing, with the aim of advancing research into the role of digital libraries in facilitating

knowledge creation and sharing. The winner of the De Gruyter Saur IFLA Research Paper Award 2015 is Ana Pervan with her paper, "The role of data curator in the CERN Particle Physics Data-Sharing Community". Pervan's paper presents original research on the role of data curators in sharing scientific data and other forms of scholarly communication. The panel judged that she employed an innovative research methodology, with findings that were relevant to both data curators and the research community.

FOCUS ON THE LTR COMMUNICATION TEAM

Our team is composed of students from the enssib (Ecole Nationale Supérieure des de l'Information Sciences et des Bibliothèques) in Lyon, France and students from the University of Denver in Colorado, U.S.A. proposes sharing features within an identified group and permits to mutualize the information monitoring of the different members on the subjects of the working group in order to:

- Gather all the information monitoring in the same space;
- Organize the results of this monitoring through the use of keywords and find them more easily thereafter;
- Widely disseminate the results among the members of the group and share them with interested persons."

The information monitoring is done by all the members of the IFLA LTR workshop of the section under the guidance of Raphaëlle Bats, information coordinator of the LTR.
